I was diagnosed with Stage 4 cancer in late December of 2004. Lung cancer that had metastasized to my brain. After having surgery to remove 1/3 of my lung and radiation on my brain, I did 2 rounds of chemotherapy and 21/2 weeks of radiation to my brain. My doctor told me nothing would really help and we would just wait to see where the cáncer would return. Besides being depressed, I was pretty lethargic most of the time and had trouble sleeping extensively at night.

I had a lung cat scan done that showed a small speck in my lung about one month after chemo and radiation. My sister found a place called the Wellness Center for me in South Miami, Florida, run by oncologist Dr. Victor Marcial Vega. I saw him in Puerto Rico and continued my care in Miami.

My treatment is I.V. therapy along with an array of nutrients and a proper diet (i.e., no sugars, no meat, and poultry for example). Much to my surprise, after approximately 5+ months my last cat scan showed nothing in my lungs. My last pest scan showed nothing in the brain either.

On February 28, 2005, I underwent exploratory surgery of the abdomen and was diagnosed with adeno carcinoma of an unknown origin (stomach cancer in the form of a granular-like substance in the stomach lining.) This caused a fluid build-up in the stomach and lung cavity, which required draining several times. On the advice of the attending physicians, I

began chemo therapy. After a series of three chemo treatments I was feeling really beat up; I had no appetite, I lost weight and felt nauseous all the time. I was determined to find something to fight the cancer without destroying my body.

Dr. Victor Marcial Vega came highly recommended to me for the work he was doing in alternative medicines, so on May 13th, 2005, I flew from California to Puerto Rico and spent a week with the "good Doctor." At the end of my stay, he put me on a regime of natural supplements, including essential oils, gave me his private cell phone number and told me to call ANYTIME. Imagine that....if you can.!

EXPERIENCES WITH CANCER October 20, 2005

In March of 2005, I noticed blood in my urine, for which I consulted Dr. Carlos Acosta Jimenez, urologist, who recommended an urgent cystoscopy that was performed on 3/8/05 at Hospital del maestro, Puerto Rico. The findings were: an aggressive carcinoma of the urinary bladder, with invasion of the distal ureter and prostate, atrophy of the left kidney and benign prostatic hypertrophy.

The procedure consisted of a transurethral resection of the prostate and biopsy of the tumor in the bladder.

Unfortunately, there were postoperative complications as I developed peritonitis and respiratory insufficiency, for which I needed an intubation and a ventilator for three days. I responded to the treatment and, after a three week hospitalization, I was in a state of weakness and malnourishment.

I consulted with Dr. Victor Marcial Vega, a specialist in Alternative Medicine, who recommended 3 Gm of Vitamin C daily, 5 capsules of Chlorella twice a day, 2 ounces of Goji twice a day and 2 tablets of Lactobacillus a day. My saliva, which was previously acidic, changed drastically towards alkalinity starting the next day.

My general state of health rapidly improved with protein supplements in the following 2 weeks. Subsequent studies showed that the bladder tumor was 4.5 cm in size. I consulted Dr. Sanchez, a uro-oncologist, who recommended a radical surgery, that was performed on 4/25/05 in the Auxilio Mutuo Hospital. Surgery consisted of a total cystectomy, prostatectomy, left sided nephrectomy and a reconstruction of a urinary bladder using the distal ileum and a urostomy. The pathology report showed removal of the tumor with surrounding tissues and the margins of resection were free of tumor. A report of the lymph nodes showed a 0.5 cm metastatic tumor in one of the 25 nodes. Presentation of my case in Tumor Board yielded a recommendation of postoperative chemotherapy, agreed upon by Dr. Sanchez.

I tolerated the surgery very well without serious complications and, besides some weakness; I started chemotherapy a month and a half after surgery. I continued the treatment recommended by Dr. Marcial Vega after surgery and subsequently.

I had an adverse reaction during chemotherapy which produced, besides a severe thrombocytopenia, extreme weakness and intestinal paralysis, which prevented me from eating much. Due to this toxicity, Dr. Ismael Torres Rosario, the oncologist in charge, recommended stopping the chemotherapy after 2 courses, which left me wondering

whether I am already cured or whether I still have a possibility of recurrence in the future.

I have no doubt that Dr. Marcial Vega's adjuvant treatment improved my nutritional state allowing me to go through the radical surgery which was needed and to recover postoperatively uneventfully, despite the subsequent delay in recovery due to the chemotherapy. I doubt that without that adjuvant nutritional treatment I would have tolerated the side effects and survived them, especially since I am 80 years old.

I recommend, with no fear of being wrong, that the adjuvant nutritional treatment is essential for all cancer cases, markedly improving the chances of cure and decreasing the incidence of side effects.

My name is Luciano di Lorenzo. I met Dr. Marcial Vega at his clinic in Miami on November 16, 1998. I was diagnosed with an aggressive lymphoma that had spread throughout my abdominal cavity. In addition, I had AIDS and my chances for cure were not good. My medical oncologist, Dr. Antunes, gave me one course of chemotherapy that gave me such severe side effects I had to be hospitalized. Despite this treatment, the tumor continued to grow. The skin on my abdomen was open

and there was tumor growing on it. I felt I did not have much time left, I was on diapers and a priest had given me the final rites. I had not been working for several months and was totally disabled. When I met Dr. Marcial he told me he could help me and not to worry. I became very angry at him since I thought he was lying to me and giving me false hopes. I was diagnosed with rectal cancer on February 3rd, 2005. It was located 10 centimeters from the anus and the tumor was 10-12 centimeters in size. After blood work and several CAT scans, my doctors recommended chemotherapy and radiation to shrink the tumor and then to remove it with surgery. I started on February 28th, 2005. During treatment I felt as though I was burning inside and a very intense heat within my body. This was very uncomfortable and painful. Two weeks later I met Dr. Marcial Vega.

I then started taking nutritional supplements he recommended during the radiation and chemotherapy. The sensation of burning and heat disappeared and my tissue and anus never got irritated during the treatment. I am a physical education teacher and I kept on working during treatment. At the end of radiation and chemotherapy, they repeated a colonoscopy and took biopsies which showed no tumor whatsoever! I underwent surgery, which consisted of an abdominoperineal resection, and there was no tumor found. Because the tumor was so large, they expected tumor in my lymph nodes but none of the nodes removed during surgery had tumor.

I attribute my healing to the Lord that put things in my path to heal my disease and to nourish me as well. I am an individual with a lot of faith and I know that He brought Dr. Marcial-Vega to my life to assist me in my nutrition and to increase my chances of clearing the tumor during radiation and chemotherapy. I even recovered my healthy color and my spiritual stillness during the treatment and all the negative side effects of these therapies disappeared when my nutrition improved.

My name is Fernando Rincon Zabala and I am a naturopathic doctor. In 1999 I started urinating blood. I had very severe pains and in December 30, 1999, they found a cancer in my right kidney at Baptist Hospital of Miami. This was confirmed at Jackson memorial Hospital of Miami. I did not wish to be

operated and started looking for a natural alternative. They put a stent to drain the urine from the kidney. My fear of surgery and conventional medicine had me eating healthier and doing natural things, but I was getting worse. I gained a total of 54 pounds, much of which was fluid, to the point that I could not put my feet in my shoes and I had pain even putting on my underwear. I was feeling tired, with fevers and a lot of pains. I had a yellowish color and I had a severe anemia that would give me trouble breathing. I continued to urinated blood and later started having blood in my stool. I developed fluid in my lungs and my doctors told me the cancer had spread to the abdominal area and that was why my stool had blood in it. My medical condition was deteriorating and I even had some mild retinal detachments that had developed over the years of being an extreme athlete which turned into bilateral total blindness. I was totally blind for months without any hope of ever seeing again, according to the Bascom Palmer **Eye Institute of Miami.**

I started a very strict diet and I then met Dr. Marcial-Vega on November of 2001. He started me on his protocol of nutritional supplements and also gave me some eye drops. He put me in front of some computers that produced scalar waves and I started to see light for the first time in many months! These computers assisted me to be at very deep levels of consciousness from which I could access and accept the energy I needed for my healing. On February 2002 I was feeling much better and I had recovered 75% of my vision to the point that I could drive at night.

On April of 2003, the doctor introduced me to a shaman(indigenous medicine man) from Ecuador named Hilario Chiriap, who gave me an herbal preparation called Natem. These are very strong disintoxicating herbs that also wake up the brain and the consciousness, herbs that compelled
